

This document summarizes the student evaluations I received as an instructor and teaching assistant (TA) at UCLA. At the end of each term, students were asked to provide responses to a series of questions and an overall rating of my teaching. Tables 1 and 2 show the overall ratings of the students who completed this evaluation form. While UCLA uses a nine-point scale, I converted these ratings to a ten-point scale for ease of interpretation. As not all students complete the course evaluations, in the last column I report the number of completed evaluations over the number of enrolled students.

#### INSTRUCTOR

As an instructor at UCLA, I developed and taught five courses. The student evaluations for four of these courses are summarized in Table 1. I do not report student evaluations for the fifth course because they were not collected.

This academic year, at UCLA's *Center for American Politics and Public Policy* I am guiding students through the process of conducting original research, teaching students how to frame a research question, develop a theory and a feasible research strategy, gather data, and write a 30-page paper. My research development seminar is part of a program through which UCLA students travel for one quarter to Washington, DC, to complete internships at public interest organizations and develop an original paper that draws on their courses and work experience. As the program accepts only 30 students from political science, economics, sociology, history, and communication studies, it allows for individualized instruction and consultation in an interdisciplinary setting. In the first row of Table 1, I report the student evaluations I received during the Fall quarter.

In addition, at UCLA I have taught two international relations courses as the sole instructor. The first class, "International Politics of Human Rights," was an undergraduate seminar for juniors and seniors that focused on how politics affects the fulfillment of human rights. This class drew heavily on my dissertation research—in fact, in week eight we discussed one of my dissertation chapters. It relied on student participation and had an important writing component. For example, each student served as discussion leader at least once and peer-reviewed another student's work. In the second week of the quarter, students submitted a four-page report on a current human rights crisis. They then developed this report into a 15-page paper in which they applied the theories and skills they learned throughout the class to their particular crisis. The students received feedback on their paper drafts from

their peers and from me, and presented their findings during the last week of the quarter. Furthermore, during the summer of 2017 I taught the introductory international relations course for undergraduates in the Department. Although not structured as a seminar, my classes required student participation and engagement. In addition to a midterm and final exam, students developed their writing skills by completing a written assignment analyzing Thucydides' Melian dialogue from "The History of the Peloponnesian War."

Besides these courses, as an instructor at UCLA I have developed courses on pedagogy and mathematics. I was selected by UCLA's Department of Political Science to develop and teach a two-week course, "Mathematical Methods for Political Science," that served as a math refresher for incoming Ph.D. students. This course covered probability theory, calculus, and matrix algebra, among other topics. I taught this course for three consecutive summers. In addition, I was selected as the Department's Teaching Consultant for the 2015-2016 academic year. In this capacity, I built on material that I had developed for UCLA's *Office of Instructional Development* to design and teach a ten-week course for new TAs, "Teaching Political Science," which covered pedagogical topics such as developing a lesson plan, classroom management, and active learning techniques.

As further evidence of my teaching effectiveness, I have collated a sample of unedited comments that I received in the open-response section of the student evaluations. My complete course evaluations are available upon request.

*"Andrea is a terrific instructor and knows exactly what she is hoping to relay and does it with great ease. Her expertise on the topic of human rights is connected to her passion for it which makes her a very reachable person in regards to asking questions. #### TEACHING ASSISTANT

As a TA at UCLA, I taught a wide variety of courses, including core classes in international relations; upper-division classes in international law, international organizations, and international relations theory; and methods courses at the graduate and undergraduate level, including game theory (*Politics and Strategy*), introduction to statistics, and the second course of the statistical sequence in the Ph.D. program at UCLA (*Statistical Methods II*). For each course, I developed original material for discussion sections, which enrolled 60 students on average. I chose to teach a different course each quarter to maximize my ability to teach across different topics and classroom settings upon graduation. Table 2 summarizes the overall ratings I received across sections as a TA. As in Table 1, I convert scores to a ten-point scale. For reference, in 2016 the average for TAs in the Department was 8.48.

My consistently high evaluations across a diverse range of subject matters and levels is evidence of my strength and versatility as an instructor. To provide another perspective on my teaching performance, I reproduce some unedited comments from graduate and undergraduate students in the next page.
